Refuse waste (landfill) ¹	0.75 tonnes
Electricity	1595 Kw H
Gas	7640 Kw H
Water	661 cm ³
Paper recycling	0.21 tonnes
Aluminium recycling	0.011 tonnes
Plastic recycling	0.028 tonnes
Glass recycling ²	0.84 tonnes
Overseas delegate travel mileage ³	840,388 miles
UK delegate mileage ⁴	14,474 miles
Speaker mileage	837 miles
Food mileage	1092 miles
Onsite mileage	8,082 miles

- ISO20121: International Standard for event industry currently being developed

- Expected in 2012
- Will lead sustainable management practices
- Global framework to encourage sustainability
